#### 4. ELIGIBILITY FOR BIDDERS:

- At the time of submission of the Bid the bidder should have valid registration with the Government of Madhya Pradesh, PWD in appropriate class. "A" Class Electrical Contractor license from M.P. Licensing Board (Electrical). However, such bidders who are not registered with the Government of Madhya Pradesh And are eligible for registration can also submit their bids after having applied for registration with appropriate authority.

- (a) The bidder would be required to have valid registration at the time of signing of the Contract.
- (b) Failure to sign the contract by the selected bidder, for whatsoever reason, shall result in forfeiture of the earnest money deposit.
- (c) Bidder should have Valid and live GSTIN Registration Number.

The following documents need to be submitted by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LOAs and execution status of each contract supported by client's certificate (Optional).
- b. Unconsolidated Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)

- c. Attested Copies of (Insert the relevant certificate) *Sales Tax/ GST registration certificate, Professional Tax Clearance Certificate, E.S.I, PAN and/or TAN Card, Excise registration certificate.*
- d. *Insert any other requirement specific to any particular Works and services.*
- e. Site is consists of loose bolder and rock beneath hence appropriate dig machine/ drill machine must have to be used. No compromise shall be admitted in this regard.
- f. Bidder must have their own machinery otherwise he should produce the rent agreement document with owner of machine in case of hiring of drilling machine.
- g. Depth items and Diameter may be change as per site condition rates of these items shall be paid according to it applicable SOR rates.
